3. That WIS. STAT. §11.0101(1) provides:

11.1101 (1) INDIVIDUAL LIMITS. An individual may contribute to a candidate committee no more than the following amounts specified for the candidate whose nomination or election the individual supports [See Figure 11.1101 following]:

(b) Candidates for state senator, \$2,000.

4. That WIS. STAT. §11.0103 provides:

11.1103 APPLICABLE PERIODS.

(1) For an individual who is a candidate for an office that the individual holds, the limits under s. 11.1101(1) to (3) apply during the term of that office.

(2) For an individual who is a candidate for an office that the individual does not hold, the limits under s. 11.1101(1) to (3) apply during the period beginning on the date on which the individual becomes a candidate under s. 11.0101 (1) (a) and ending on the day before the term of office begins for the office sought by the candidate.

6. That Friends of Alberta Darling's acceptance of the contributions listed above was a violation of WIS. STAT. §§ 11.1101(1) and 11.1103.

7. That the Commission agrees to compromise and settle this potential action upon payment of \$3,075.00.

8. That Friends of Alberta Darling has paid a forfeiture of \$3,075.00 to the Ethics Commission in settlement of this matter.
